

Market Wrap-Up

Indian equity indices ended with minor gains on Tuesday. The Sensex closed marginally higher by 94.71 points or 0.25% to settle at 38,067.93 levels while Nifty closed higher by just 25.15 points or 0.22% to close at 11,247.55. About 1,226 shares advanced, 1,388 shares declined, and 157 shares were unchanged. Among the BSE sectoral indices, gains in pharmaceutical and auto stocks capped losses as the financial stocks tumbled. BSE Small-Cap index closed flat by 0.04%, whereas BSE Mid-Cap index gained by 0.05%.

In global markets, Asian indices such as Shanghai index and Nikkei closed lower by 0.20 % and 1.53 %, respectively.

Sector and Economic Update

India's infrastructure output fell by 8.5% y-o-y in August 2020. Following a downwardly revised 8% drop in July. It is the 6th straight plunge in infrastructure output. All sectors showed a decline in production except fertilizers and coal. Declines were seen in refinery products (-19.1 % vs -13.9 %); electricity (-2.7 % vs -2.5 %); steel (-6.3 % vs -8.3 %); crude oil (-6.3 % vs -4.9 %); natural gas (-9.5 % vs -10.2 %); and cement (-14.6 % vs -13.5 %). On the other hand, coal production rebounded (3.6 % vs -5.7 %) and the output for fertilizers rose faster (7.3% vs 6.9 %). Considering the first five months of this fiscal year that started on April 1st, industrial output shrank 17.8% compared to a 2.5% expansion for the same period previous year.

Corporate Update

- Government of India (GoI) has extended the last date for submission of Expression of Interest (EOI) for strategic divestment of BPCL to 16th November 2020. GoI holds 52.98% stake in BPCL as on 30th September 2020.
- Ramco Systems has signed up an agreement with a Global Top 5 logistics major for modernizing and transforming its multicountry Payroll operations on Ramco's Global Payroll platform. The company will be unifying its payroll operations for 15 countries across Middle East & Africa. With this win, Ramco Global Payroll is now trusted by two of the top 10 third party logistics companies, globally.
- Tata Consumer Product (TCPL) is likely to offer Rs.1000 crore to take over the vending machine business of Coffee Day enterprise Ltd. (CDEL). But CDEL has put a Rs.2000 crore tag on its vending machine operations. TCPL reported consolidated revenue of Rs.9600 crore for FY20.
- After Silver Lake and KKR, now General Atlantic, a global growth equity firm will invest Rs.3675 crore into Reliance Retail Venture, a subsidiary of Reliance Industries. This investment values Reliance Retail at a pre-money equity value of Rs.4.285-lakh crore. General Atlantic's investment will translate into a 0.84% stake in RRVL on a fully diluted basis.
